SEIZING TIME

This year's edition of the Festival will be forever marked by a tragedy. Our artist of honor, Leila Alaoui, was killed six weeks ago in the attacks in Ouagadougou. Full of humor, ideas, and a bright future ahead of her... her life was suddenly taken away. Leila who always took her time, the time to be present for the people she loved and those she met in her work: she treated the subjects of her work, thoughtfully and carefully, before presenting it before our eyes. Tragically, Leila did not know it was only a matter of time.

“We don't have time!” Time consumes us. We are busy. Overwhelmed with information in an increasingly complex world, often without a filter or a net. There are so many suffering people in the world, but so little time to consider their perspectives. So little love.

For once, we will not allow this to be a matter of time. We will seize the moment to watch films and engage in passionate debates. Following Typhoon Haiyan, Brillante Mendoza grabs his camera and begins filming a thrilling and suspenseful work on the trail of carnage. Amos Gitai captures Rabin's assassination in this 2 hour 30 min. masterpiece. Two films from two eras, that are both contemporary and perfectly timeless. Like all of the reputed featured films, it takes dedicated work and patience to successfully take us beyond our confines and into the world of others.

There are many others to recount, to be presented in different art forms. In revealing the stories of refugees, we are proud to present a theatrical performance, a video, a participatory project and a photography exhibition. Short artworks, that resonate in the longterm.

A picture is worth a thousand words ... but like our time and our love, we are unable to count our words when we look at an image. We do not know what the future holds. Let's focus on the present, by participating in captivating debates, that lead us from Mexico to Eritrea, and Riyadh to Paris. We know that the ideal world does not exist, but we will witness the actions of people who have not given up on making the world a more just and beautiful place. We will listen carefully, and question sincerely, because like democracy and our values, to be alive, to move, and to be in balance are in constant states of questioning and reinventing.

The aim of this festival is to create, on a small scale with the help of a wonderful team, a place to experiment, where people can gather and make a change. A place where we erase our fears and where we dare to be courageous. A place where we create resistance.

A dynamic place, against all odds. A place that Leila would have hoped for.

LEILA ALAOUI, HONOURED ARTIST AT THE FIFDH 14TH EDITION

The face of a young shepherd, determined and proud. His eyes burn with “Hrag”, a term to describe the fire that rages in the hearts of those in the southern Mediterranean, willing to burn their past and sacrifice everything to reach the shores of Europe. This image is powerful: it bears witness to hundreds of stories, thousands of beings and millions of hopes. This beautiful photograph taken from Leila Alaoui’s work *No Pasara in Tangier* is the face of the FIFDH poster this year.

Leila Alaoui, a unique artist, has traveled throughout Africa and the Middle East alongside migrants, water transporters, refugees and those forgotten along the road of history. With incredible talent, she documents their lives, offering a sense of pride, a means of identity, and a powerful story.

We are honored to present her work at the FIFDH: for eight months we were anticipating her arrival in Geneva. Confirmed as the Artist of Honour at this year’s Festival, she had planned to present the FIFDH poster, her exhibition,

and take part in an artistic residency in Meyrin. But in January, two weeks before her arrival, the unthinkable happened: the life of the joyous and talented Leila Alaoui was tragically cut short in the attacks in Ouagadougou.

It is with great honour that we present the exhibition she had prepared for the FIFDH: *Natreen*, a project undertaken in the Syrian refugee camps of Lebanon. As part of the exhibition, the artistic residency in Meyrin will host a period of reflection and discussion about her work.

Leila's vision of the world is a gift to us all. Just like her light.

Leila ALAOUI is a French-Moroccan photographer and video artist whose experiences across different cultural and geographic environments inform her critical and creative practice. Born in Paris in 1982, she studied photography at the City University of New York before spending time between Morocco and Lebanon. Her work explores the construction of identity and cultural diversity, often through the prism of the migration stories that intersect the contemporary Mediterranean. Her images express social realities using a visual language that combines the narrative depth of documentary storytelling and the aesthetic sensibilities of fine art.

Her work has been exhibited internationally since 2009, including at the Institut du Monde Arabe, Art Dubai and the Maison Européenne de la Photographie in Paris. Her photographs have been published in newspapers and magazines including *The New York Times*, *Vogue* and *The Guardian*. Leila’s humanitarian engagement involves photographic assignments with respected NGOs, including the Danish Refugee Council, Search for Common Ground and the UNHCR.

In January 2016, during a photographic assignment on women’s rights in Burkina Faso commissioned by Amnesty International, Leila fell victim to the terrorist attacks of Ouagadougou. She succumbed to her wounds on January 18th, 2016. The Leila Alaoui Foundation is being set-up to preserve her work, defend her values, and inspire artistic engagement for human dignity.

In November 2013, the international humanitarian organisation Danish Refugee Council (DRC) commissioned artist Leila Alaoui to create a photographic series illustrating the conditions of the more than one million displaced Syrians in Lebanon. In coordination with DRC staff, Leila toured Lebanon to meet the men, women, and children of the crisis. While her portraits reveal the tragic experience of displacement, Leila's artistic sensitivity critically captures the hope and resilience of a people, underlining their humanity and giving them back a sense of dignity.

Barbara Hendricks

President of the Jury

Opera singer

After receiving a bachelor of science, Barbara Hendricks has performed on the world's biggest stages and has been directed by the most prestigious conductors of our time. Her vast repertoire spans from baroque to contemporary opera, concert, chamber music and jazz. In 2006, she created *Arte Verum*, her own label. As a devoted human rights activist, she is the UNHCR's Honorary Ambassador for Life. She played for Luigi Comencini in *La Bohème*, and for Amos Gitai in *Disengagement*. She was a member of jury at the Cannes International Film Festival in 1999. Barbara Hendricks has patroned the FIFDH since its very first edition.



Plantu

Press cartoonist

Jean Plantureux, a.k.a Plantu, published his first cartoon on the Vietnam war in *Le Monde* in 1972, for which he eventually became a daily illustrator in 1985. Since 1991, he has published a weekly page in *L'Express*. That same year, he received the "Rare document prize" from the Festival du Scoop d'Angers, for having succeeded in obtaining the signatures of Yasser Arafat and Shimon Peres on the same drawing, a year prior to the Oslo Agreements. In 2006, Plantu and Kofi Annan, Secretary General of the United Nations, founded Cartooning for Peace, an association currently made up of 130 illustrators, which defends freedom of expression for cartoonists worldwide.



Philippe Djian

Novelist

Philippe Djian is a French novelist who won the Interallié Prize in 2012 for his novel *Oh...*. Many of his books have been adapted for the screen, such as *37,2 le matin*, directed by Jean-Jacques Beinex. As a lyricist for Swiss artist Stéphane Eicher, he associated himself with him during literary concerts. Audacious and nomadic, he also published a report on the army and guerillas in Colombia and set up long-term residences in both New York and Martha's Vineyard. His next novel *Dispersez-vous, ralliez-vous* will be published in March 2016.

Ece Temelkuran

Novelist and journalist

Ece Temelkuran is one of the most famous Turkish journalists. She has regularly contributed to the very popular national daily newspapers *Cumhuriyet* and *Milliyet* and with CNN Türk. She is also a TV producer and author of several books such as *Banana Sounds* (2010). Her writing and opinion pieces in favour of women, political prisoners and against the raw tensions in East Turkey have garnered numerous prizes including the Pen Peace Awards in 2001.



Daniel Schweizer

Film Director

Daniel Schweizer is a film graduate of Beaux-Arts Genève as well as the École Supérieure d'Études Cinématographiques of Paris. He became a freelance assistant-director for Swiss TV (RTS) in 1983. He turned to self-employment in 1993 and was noticed for his documentaries on right-wing groups and the skinhead movement as in *Skinhead Attitude* or *White Terror*. He received the FIFDH's Grand Prize in 2010 for *Dirty Paradise*, the first film of an ongoing series on Amazonian people. He also teaches at HEAD – Geneva since 2005.





Nabil Ayouch

President of the Jury

Film Director

Nabil Ayouch is one of the foremost Moroccan directors. Following *Mektoub* (1997), *Ali Zaoua*, *Prince de la rue* (2000, selected to represent Morocco at the Oscars), and after the outstanding international success of *Whatever Lola Wants* (2008) and *Les Chevaux de Dieu* (2012), he presented his latest film *Much Loved* (2015) at this year's Cannes Festival. Despite great critical acclaim, the film was censored in Morocco and Nabil Ayouch became the target of a vast smear campaign and death threats. He is also a founder of both the Moroccan coalition for cultural diversity (2003) and Media Films Développement (2006), which supports producers and scriptwriters from countries south of the Mediterranean. *Much Loved* will be screened at the FIFDH on March 7th.



Marcela Zamora

Film Director

Marcela Zamora Chamorro is a Nicaraguan and Salvadoran filmmaker. After studying journalism in Costa Rica, she graduated from San Antonio de los Baños, a prestigious film school in Cuba. For over 12 years, she has directed many films, both fiction and documentary, that have been shown the world over, most notably *Maria en la tierra de nadie* (*Maria in Nobody's land*) about migrants, and *El Cuarto de los Huesos* (*Nobody's Bones*) on the lost people of Central America. She has also worked for TV, on channels such as Al Jazeera and Tele Sur. She currently heads the documentary section of Salvadorian digital newspaper *El Faro*.

Aude Py

Scriptwriter

Holding both Swiss and French passports, Aude Py studied philosophy at the Sorbonne before becoming a scriptwriter. She notably collaborated on the writing of Christian Caron's *Joyeux Noël* (2004) and Bertrand Bonello's *Tiresia*, before earning a co-writer credit for Erick Zonca's *Julia*, with Tilda Swinton in the title role. She has just co-signed the script for the upcoming adaptation of Jacques Chessex's *Un Juif pour l'exemple*, directed by Jacob Berger. She is currently completing the fiction short-film *Splendid*, co-directed with Bruno Ulmer, which tackles the issue of undocumented migrants in Geneva.



Philippe Cottier

Lawyer

Philippe Cottier is a swiss lawyer, member of the Hélène and Victor Barbour Foundation since 1995 and Secretary of the Foundation's Council since 2005. He represents the foundation in different cultural activities it is involved in. He has always held a strong interest in cinema and his participation in the Barbour Jury Prize for the FIFDH's 2016 edition is proof of his continued artistic engagement.

SAUDI ARABIA: HUMAN RIGHTS SENTENCED TO DEATH

Under the banner of the fight against terrorism and on a fertile soil of economic interests, the Saudi Kingdom forges alliances with the international powers. Meanwhile, the country is pointed at for its desperate human rights record.

Famous for its conservatism, the Saudi regime reserves the right to punish any challenge to Islam or the monarchy. Invoking Sharia, it can apply the death penalty for crimes such as murder, rape, drug trafficking, but also adultery or apostasy. In thirty years, more than 2,200 people were executed, including the mentally disabled and minors. The sentencing of Ali Mohammed al-Nimr to be beheaded then crucified for protesting when he was 17 years old, or that of the blogger Raif Badawi to 10 years in prison and 1,000 lashes for questioning Islam, sparked international outrage.

The country is also known for its sinister women's rights situation. A male guardianship system requires consent to travel, marry or study, and women have only recently obtained the right to vote.

Despite the alarming human rights record, a Saudi representative was appointed head of an advisory committee at the Human Rights Council in 2015. In the name of the "realpolitik", many countries equally provide financial, military and political support to the Wahhabi kingdom. Thus, they silently approve the human rights violations, as well as the dramatic consequences of the Saudi-led coalition in Yemen.

The film *Saudi Arabia, A Wind of Change?* is a foray into a secret world, revealing, on the background of economic prosperity, the challenges faced by Saudi women.

FUNDAMENTAL LIBERTIES IN RUSSIA, A FORGOTTEN CONCEPT?

Analyses of today's Russia are passionate and contrasting. Amidst the debate, human rights defenders are warning against the signs of a repressive regime, targeting the dismantling of diversity and fundamental freedoms.

The Russian government's policy raises both criticism and fascination of Western media, observers and politicians, whether it concerns internal governing approaches, or decision-making in international affairs.

Civil society denounces a political discourse and legislative climate limiting fundamental rights and freedoms, restrictions that the authorities justify by the need to counter the Western "enemy". Since 2012, laws are multiplying to isolate undesirable NGOs, marked as "foreign agents". Journalists, political opponents, artists and ordinary citizens are threatened, imprisoned or silenced when they peacefully exercise their rights to assembly or freedom of expression. Justice is undermined and corruption infects all branches of the State. The repression of LGBT persons and the emphasis on "Russian values" contribute to a climate that is hostile to social and cultural diversity. However, other observers denounce Western simplifications, highlighting the complexity of Russian history and politics.

Are fundamental freedoms, at the cornerstone of any democracy, a forgotten concept in a country positioning itself as one of the world's economic and political leaders?

The film *Boris Nemtsov - Shot in the Shadow of the Kremlin* presents the biography of the former Deputy Prime Minister who became the most famous opponent of Vladimir Putin, and takes us behind the scenes of Russian politics.

CLIMATE CHANGE: ACTING FOR THE PLANET AND HUMAN RIGHTS

Climate change is inseparable from human rights. While politicians, businesses and citizens are increasingly aware of climate risks and challenges, the choice of solutions to address the phenomenon is pressing.

Death, disease, climate refugees, shortage of water and food, austerity policies, marginalization of vulnerable people: climate change and environmental degradation have real consequences on human rights in the world.

In response to the urgency of climate change, the 195 States that participated at COP21 concluded a universal climate agreement. Internationally acclaimed as a historic moment in the fight against climate change, the results are nevertheless mixed. The agreement puts forward the principles of a “green” economy, but fails to mention the responsibility of States to respect human rights in a binding form. Amidst political debates, citizens commit themselves to preserving the planet, our common living space. Urban farms, alternative education systems, complementary currencies: innovative solutions worldwide advance on the fight for environment and social justice. Provided we act together, another world is possible.

What are our options when faced with the unprecedented challenge of climate change? And, while taking climate action, how to ensure that the transition to a low-carbon economy remains aligned with human rights?

Highlighting the incompatibility of our current development model with the wellbeing of our planet, the film *This Changes Everything* illustrates the struggle of civil society to break the system and create a sustainable, just and equitable world.

Paradoxically, to protect citizens from terrorism they are asked to renounce certain freedoms. This is precisely what the terrorists seek, to destroy the freedom and a way of life that found the values of our society.

It is in the strongest terms that we must condemn terrorism. Equipping ourselves with the means to fight it is just as necessary. But the fight against terrorism should not be detrimental to civil liberties and should be carried out within the limits of respect for human rights.

The Patriot Act is an example of possible abuses resulting from counter-terrorism. Repression of the opposition in Turkey, criminalisation of journalists in Egypt, reintroduction of the death penalty in Tunisia, new anti-terrorism laws and a prolonged state of emergency in France... Despite the many reported slip-outs, French authorities decided to extend the latter.

From a human rights standpoint, how do we resist these measures and preserve the Rule of Law? What are our options when faced with a new type of terrorism, such as the one carried out by Daesh, provoking a rare violence and appealing to a certain youth? Does the end justify all means? What can be done to prevent youth radicalization?

The words of Nobel Prize Albert Camus strike us as just and topical: "And this is why I have decided to reject everything that, directly or indirectly, for good or bad reasons, makes people die or justifies others in making them die."

The film *Jihad, A Story of the Others* offers a perspective of the phenomenon on the radicalization of young Westerners, its origins and possible solutions.

A unique and collaborative art exhibit with film screenings testimonies, drawings, photos and video clips. Investigative journalist and director Anne-Frédérique Widmann and cartoonist Patrick Chappatte, joined by a death row inmate freed after 28 years in detention, illuminate the brutal reality behind the walls of death row in the United States.

It is the dustbin of America: approximately 3,000 death row inmates are locked up in solitary confinement, in a cell the size of a bathroom, up to 23 hours a day, for 15, 20, 30 years, pending execution. During a one year stay in the United States, Anne-Frédérique Widmann, an investigative journalist at RTS and documentary filmmaker, and Patrick Chappatte, cartoonist at *Le Temps*, have established contacts with thirty detainees, visited high security prisons across the country and led drawing workshops for those on death row. In order to expand the conversation on capital punishment in the U.S., they asked the inmates to share their lives in the form of text, drawings and paintings. These images, combined with sketches by Patrick and filmed interviews by Anne-Frédérique, guide the narrative of this journey.

They will be joined on stage by a man with an exceptional destiny, Ndume Olatushani, sentenced to death for a crime he did not commit and released from prison after 28 years of detention, by Ruth Dreifuss, former Federal Councillor and Robert Badinter, former french Minister of justice, who will discuss the fight for universal abolition of the death penalty.

Can international pressures put an end to the Israeli occupation? Will they contribute to the recognition of a State of Palestine and lead to a peace agreement? To guarantee respect for human rights, dialogue between Palestinians and Israelis must be strengthened.

Twenty years since the murder of Rabin, the Israel-Palestine situation is tense and peace seems a faraway perspective. The peace defenders are worried. Israeli and Palestinian citizens, but also citizens of the world of all confessions and cultures, call for a political solution and the re-launch of the negotiations process.

As the situation worsens, the conflict exacerbates hatred and mistrust. However, a different voice rises. This voice firmly denounces the Israeli government policy and demands the end of the occupation of Palestinian territories. It calls for the recognition of the Palestinian state and stronger dialogue between the two peoples.

Despite the many barriers faced on both sides, many civil society organisations, as well as Palestinian and Israeli personalities engage on this path: Leila Shahid, David Grossman, Ali Abou Awad and Daniel Barenboim, to mention a few.

How best to support the efforts of peace activists? Can a movement, uniting Israeli and Palestinian citizens, contribute to establishing peace between the two peoples? We ought to go beyond declarations, to allow peace to become an everyday reality. Without peace, both Israeli and Palestinians are condemned to a life of despair.

Portraying a family's personal journey over a number of years, the film *P.S. Jerusalem* attempts to bring closer two disparate communities in the context of a Palestinian-Israeli school.

DRC: BREAKING THE SILENCE! WOMEN DEMAND JUSTICE.

The eastern Democratic Republic of Congo (DRC), a region rich in mineral resources, is torn apart by two decades of bloody conflict, where rape is massively used as a weapon of war. The numbers are staggering: since 1996, at least 500'000 people were brutally raped. None are spared, including babies, pregnant women, men, and seniors. These atrocities continue every day, in a chilling silence.

“In DRC, rape is a weapon of mass destruction” says Dr. Denis Mukwege, who for sixteen year has provided free treatment to women and children victims of sexual violence at the Panzi Hospital in South Kivu. His fight is retraced in the documentary *L'homme qui répare les femmes - La colère d'Hippocrate* by filmmaker Thierry Michel, co-written by Colette Braeckman, which will be presented at this exceptional event.

This film was initially banned in the DRC then released in January, following mounting international pressure. It is a burning topic: winner of the Sakharov Prize in 2014 and nominated several times for the Nobel Peace Prize, Dr. Mukwege has survived six attacks and lives cloistered in his hospital, under the protection of the women he cared for and who work beside him.

What is the Congolese government doing to address these injustices? President Joseph Kabila appointed a special representative in 2014 for the fight against sexual violence. Modest actions were taken, but there is still much progress to make.

Following a presentation at the FIFDH, Doctor Mukwege will take part in a plenary session at the Human Rights Council at the United Nations, Tuesday March 8th.

DESTRUCTION OF WORLD HERITAGE: A WAR AGAINST HUMANITY

In its Universal Declaration of 2001, UNESCO recognizes cultural diversity as the “common heritage of mankind”. It is an imperative inseparable from the respect for human dignity.

The Islamic State of Iraq and the Levent (ISIS) militants have declared a war against our past and culture in Palmyra, Nimrud, Mosul and Hatra, erasing history and imposing terror to the populations under their rule. The massacre of people goes hand in hand with the destruction of cultural heritage. Millennia sculptures are wiped out on the grounds of their pre-existence to Islam, and everything that doesn't conform to an ISIS interpretation of the Koran is at risk. According to Irina Bokova, Director-General of UNESCO, this crime is “part of a strategy of deliberate cultural cleansing of exceptional violence”. The first prosecution by the International Criminal Court for the destruction of world heritage in Mali under war crime charges is, nevertheless, hopeful.

Although ISIS captures the headlines, cultural heritage is targeted by other groups, including state actors, and beyond the borders of Syria and Iraq. At the same time, the trade in looted antiquities is used to finance the terrorist organization, a practice quietly observed by the West.

What is at stake in the protection of world heritage? What are our tools to preserve heritage? Are the actions of the international community effective and adequate?

The Giant Buddhas is a documentary about the destruction of the famous Buddha statues in Afghanistan.

SEX SLAVERY – MORE THAN A WEAPON OF WAR, A THEOLOGICAL INSTITUTION

In 2014, following the seizure of the Iraqi Sinjar region, Daesh fighters massacred hundreds of men and forced thousands of Yazidi women and children into slavery. A practice that was later codified in the name of theological principles.

Countless women and children, mainly from the Yazidi minority, are still held captive by the Islamic State of Iraq and the Levant (ISIL) and subjected to brutal sexual abuse. Rape, trafficking and forced marriage are systematic, enforced through a rigorous infrastructure and detailed bureaucracy. These inhumane practices are not concealed. On the contrary, ISIL released and distributed to its followers a “rape handbook”, codifying the rape of hostages with detailed rules and regulations, and containing the new “sexual policy” to adopt towards captive women and children. These practices, justified by ISIL fighters as being rooted in the Koran, are part of a “theology of rape” and serve to further strengthen the authority and spread of the terrorist organization.

How to explain this form of slavery in the modern age? What can we do to counter this phenomenon? How can the dignity of victims be restored? Many women and children still suffer from ISIL's barbaric treatment, and those who managed to escape are in urgent need of help and support.

The film *Escape from ISIS* takes us to the heart of the daily life of Al-Khaleel Dakhi, a lawyer from Sinjar and a member of an underground network fighting to rescue young women trapped by Daesh.

The production of our clothing is done in certain countries at the cost of human dignity and sometimes life. Governments, businesses and consumers share the power to make the clothing industry more responsible.

To lower production costs, multinational enterprises are often reported to place their activities in countries with a poor record of workers protection. Life-claiming disasters such as the Rana Plaza accident in Dhaka in 2013, or the fire at a shoe factory in Manila in 2015, put the spotlight on the inhuman working conditions that exist in the supply chains of popular Western brands.

While these disasters led to progress on labour law issues such as workplace safety and victim compensation, more can be done to avoid such tragedies. This implies the shared responsibility of all stakeholders, from production to consumption.

What are the obligations of Governments when it comes to labour standards? What does accountability of enterprises look like? What justice for the victims? And ultimately how can the consumer help to make the clothing industry more accountable?

The True Cost is a story about the clothes we wear, the lives of the people who make them and the impact of the garments industry on the world.

The United Nations Declaration on the Rights of Peoples (2007) recognizes the rights to land, territories and natural resources as “an essential component of indigenous peoples’ culture, spiritual life, integrity and economic survival”.

Nevertheless, governments across all continents allow enterprises to exploit these ancestral lands. Causing irreversible damage to the environment, they also threaten the physical and cultural survival of indigenous peoples. These peoples engage in an emblematic fight against a cultural cleansing that puts at risk their way of living, thinking and perceiving, forcing them to adapt to a dominant and devastating culture.

The United Nations estimate that approximately 2,500 languages are in immediate danger of disappearing, and an even greater number are losing their ecological context, due in great part to globalization and expansion of world markets. In Mexico, for instance, Canadian mining companies have bought concession rights and are legally exploiting the sacred land of the Huichol Indians, despite international principles protecting indigenous peoples’ rights. The Huichol Indians, like many other indigenous peoples, are fighting against land grabbing.

What is the State's responsibility towards these too often neglected populations? How to tackle the lack of coherence between internationally recognized indigenous people's rights and business activities? What can we all do to support and promote indigenous peoples rights?

The film *Voix d'Amazonie* exposes the struggle of indigenous peoples in Ecuador against oil exploitation on their sacred lands.

COUNTERING ORGANIZED CRIME, FROM ITALY TO MEXICO

“At this moment, the fiercest, most powerful criminal organizations in the world are located in Mexico,” stated Roberto Saviano, bestselling author of *Gomorra*, following the disappearance of 43 students in Iguala in September 2014. The case remains unsolved, but the cartels and the complicity of the local police are suspected.

Organized crime is rampant, but the case of Italy and Mexico are particularly marked. The “narcos” are not just Mexican drug traffickers. Like the Italian mafia, their power lies in all spheres of society. Nearly 500,000 people work directly for the cartels, making it the largest employer in Mexico, offering varied and better-paying jobs than the legal market.

In Italy, the mafia's structure of organized crime was revealed after the attacks in 1992-93 that claimed the lives of judges Falcone and Borsellino, colleagues of our guest, the Attorney General of Palermo Mr. Roberto Scarpinato. Hundreds of trials followed, revealing implications at all rungs of the social ladder. Entrepreneurs, deputies, doctors or teachers, hundreds of white-collar workers were convicted. Anti-mafia laws have drastically reduced violence linked to organized crime.

While Mexico is steeped in violence and corruption, the offensive strategy of the war against “drugs” is marked by inefficiency. The Oscar-nominated film *Cartel Land* by Mathew Heineman reveals how the use of violence to counter violence has plunged Mexico into a downward spiral.

The case of Italy suggests a more powerful weapon than violence: the use of the law.

Current conditions of asylum and protection of refugees do not respect the fundamental rights enshrined in the 1951 Convention relating to the Status of Refugees.

While millions of persons find refuge in Jordan, Lebanon and Turkey, many are trying to reach Europe in the hope to find better asylum conditions. These refugees have already been through traumatic experiences in their own country and on their journey to Europe. The exodus is even worse for women, who may face physical assault from fellow refugees, smugglers and police, and for children, who can face detention because of their migrant status.

Unfortunately, there is no common will of European countries to respond to this tragedy. On the background of a fragmented European asylum and migration legislation, States act in their own interests.

Fuelled by wars in the Middle East, repressive political regimes and stark economic prospects, the rise in migration in Europe is the largest since World War II. Faced with such a tide of human despair, do we build walls or make a human and generous gesture? In 2015, only Germany and Greece have shown their commitment to European values, receiving countless refugees.

Does Europe respect the fundamental rights of refugees? Have the principles enshrined in the 1951 Convention relating to the Status of Refugees been forgotten? Isn't it time for Europe to reaffirm its founding values that had led to its foundation?

“Democracy has failed. Dictators have failed. Now there is a vacuum. Someone has to fill it”, announces the film’s crew, which offers a phenomenal entry point at the heart of the ideological struggles currently dividing the Muslim world.

In Pakistan, a country ravaged by misery, the struggle for power between extremists, moderates and seculars is particularly vicious, the major issue being education. While activist Pervez Hoodbhoy makes public appeals in favour of secularism, the Red Mosque’s crooked and fanatic preacher, the charismatic Abdul Aziz Ghazi, has become a master in the art of influencing young “malleable minds”. In December 2014, the massacre of 132 schoolchildren in Peshawar will spark a crisis.

The discussion will address radical islam as a social phenomenon, from an anthropological point of view.

PEACEKEEPER: FROM TRUST TO ABUSE?

Investigating allegations of sexual abuse of children by peacekeepers in the Central African Republic, an independent expert report denounces the United Nations' failure to respond. Between bureaucracy and a legal vacuum, crimes go unpunished.

Since 2004, soldiers enrolled in peacekeeping missions were accused of committing sexual abuse of minors in the Central African Republic (CAR), Mali, Haiti, Ivory Coast, the Democratic Republic of Congo and Burundi. Crimes going as far as implication in human trafficking already took place in the 1990s in Bosnia and Kosovo.

The United Nations Secretary General declares a “zero tolerance” policy for such crimes. In 2015, he appointed an independent commission to investigate allegations of sexual abuses by French and African soldiers in CAR. The commission’s report revealed that the soldiers, taking advantage of the economic devastation on the ground and their trusted status, offered food in exchange for sexual acts with children. The children were between 9 and 15 years old.

Benefiting from immunity in the countries where they are deployed, these soldiers can only be prosecuted by their sending State. Made possible by a legal void and bureaucracy, impunity for these crimes constitutes a double assault on human dignity.

What are the safeguards against wrongdoings by peacekeepers? How to hold perpetrators accountable? What protection for those who break the silence? What remedies are there for the victims?

Le Déshonneur des casques bleus describes the dismay of a population whose children have become the prey of international peacekeepers, and their fight for justice.

FIFA has gone so far as to include human rights in its policy priorities and core work. What are the ongoing reforms? Are they effective?

Can promotion of human rights become a new Olympic sport?

ERITREA, THE RULE BY FEAR

An inaccessible and low profile country, Eritrea is known especially for its documented refugees, who arrive or fail at the gates of Europe. A ferocious dictatorship reigns in the country, under the tacit gaze of the West.

A United Nations report on human rights in Eritrea recently stated: "It is not law that rules Eritreans, but fear."

Since the independence of Eritrea in 1993, Issayas Afewerki's regime has systematically committed widespread violations of human rights and fundamental freedoms with impunity. In over twenty years, no opposition party has been formed and no elections have been conducted. The human rights situation in Eritrea is dismal: lifelong military service, controlled religious practice, food quotas, arbitrary detention, including of children, the principle of guilt by association and a record number of prisoners of conscience held in underground prisons.

Despite the fact that there is no conflict currently in Eritrea, the country stands second in terms of refugees, only behind Syria. Eritreans massively flee their country, endangering their lives through risky routes.

Western countries seek solutions to the refugee crisis. At the same time, investigations reveal their tacit complicity with the Asmara regime. In Europe, namely Switzerland, banks are allegedly serving as vaults for the Eritrean dictator's finances. Swiss public and private actors should be able to sanction these policies that disregard human rights.

The film *Voyage en Barbarie* follows the journey of young Eritreans fleeing the dictatorship through the torture camps in the Sinai region.

educational program

March, 7th to 11th

In promotion of the United Nations' human rights agenda, the FIFDH has organized since 2004 an educational program for students of the Geneva canton to engage in issues related to human rights violations.

This program is organized with the support of the Canton of Geneva, in partnership with Amnesty International, the United Nations High Commissioner for Human Rights in collaboration with Peace Brigades International, Doctors Without Borders, the Eduki Foundation, Ciné Civic, the Geneva Museum of Ethnography, the International Museum of the Red Cross and Red Crescent and the Municipal Libraries of Geneva.

PROJECTIONS AND VISITS

From March 7th to 11th, documentary film screenings will be followed by discussions with specialists, actors and actresses, and victims of human rights violations who will share their experiences with the students. These discussions are moderated by Angelique Duruz, education coordinator for human rights at Amnesty International. This is a unique opportunity for young people to take the floor and express their opinions.

This year we are strengthening our partnership with the Museum of Ethnography, the International Museum of the Red Cross and the Municipal Libraries, by offering educational courses around issues of power, the multiple facets of disorder and the death penalty. This two-part course (film screening and exhibition tour) – is addressed to secondary school students.

CONTEST FOR YOUNG REPORTERS

Contest participants will be provided press accreditation badges. Walking on the sidelines of the Festival, students will be surrounded with professional journalists, attend screenings and discussions, and meet prestigious guests with the possibility to write a final report. This is a unique opportunity to experience the Festival from the inside!

All productions will be published on the blog www.ecolesfifdh.ch and a jury of professional journalists and photographers will award the best works.

YOUTH JURY

Secondary school graduates will participate in a Youth Jury for fiction and documentary films, with the opportunity to develop their curiosity in film, critical thinking and awareness of human rights. Participants will review films selected for the competition alongside an international jury. In addition, they will announce the prize winners of the Eduki Foundation and the International Peace Brigades.

JURY OF THE CLAIRIERE DETENTION CENTER

The FIFDH offers young people from the Clairière Detention Center full access to films followed by discussions with the filmmakers.

At the end of the project, young people will present a Clairière Jury Prize, which will be announced along with the official winners of the Festival.

Over the course of four weeks, the workshop, headed by Fernand Melgar, aimed at capturing the irreducible difference of the city beyond the picturesque.

Eight films were completed in Geneva thanks to the collaboration between the FIFDH and the RTS. These short films, which are based on true stories, will be presented for the first time.

A genuine reference of contemporary art cinema, Filipino filmmaker Brillante Mendoza distinguishes himself through an intensely personal aesthetic research and formal approach.

A publicist at first, Brillante Mendoza began his filmmaking career at the age of 45. Since then, he has directed a total of 16 films over the course of a decade. Celebrated by critics, he broaches subjects such as homosexuality (*Le Masseur*, 2005, awarded at the Locarno International Film Festival), life in the sex industry (*Serbis* in 2008) and filiation (*John John* in 2007). He also took an interest in the issue of the Manilla mafia in *Kinatay*, which eventually won the Best Director prize at Cannes in 2009. In 2012, he directed *Captive*, in which Isabelle Huppert works for an NGO and is taken hostage in the Philippines.

Following people's intimate daily lives, often direct with his neorealist approach, Brillante Mendoza touches the secret magic of things and their sensuality. Though always oblique, his critique of the Filipino political system is no less omnipresent.

His latest film *Taklub* will be screened in competition at the Festival and will be screened in his presence on Thursday March 10 at 9 pm.

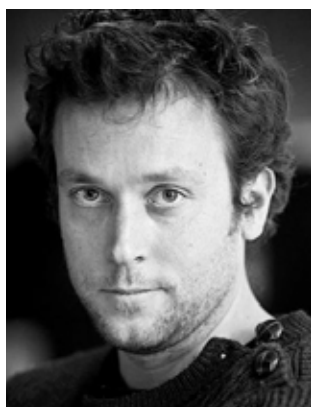

Tragedy Reloaded is a pluridisciplinary theatre production directed by Maya Bösch (2015 to 2016).

This new creation by the Compagnie Sturmfrei is intended as an exploration of the universal, intellectual, ethical and political aspects of humanity. It was performed last September at Festival de la Bâtie.

By juxtaposing two founding texts of European theatre (the tragedy of *Aeschylus*' Female Chorus and Jelinek's contemporary tragedy *Animals*), Maya Bösch interrogates the possibility of creating the world differently. By bringing together women of different generations, cultures and professions, the director gives new power to the chorus, a staple of ancient theatre.

From Aeschylus' Greece to contemporary Lampedusa, via sexual markets, these women evoke the haunting questions of asylum, exile, and what it means to be a woman. Their screams resonate.

ESCAPED

Seivan Salim will participate in the “*Sexual slavery – more than a weapon of war, a theological institution*” debate on Tuesday, March 8th.

In August 2014, Daesh fighters took the town of Sinjar in Northern Iraq, an ancient crossroad of ethnical and religious diversity, where Yazidis – an ancient monotheistic community, with roots in Zoroastrianism, Christianity and Islam – live. During the weeks that preceded the town’s downfall, the djihadists murdered thousands of people and kidnapped more than 5,000 women, who were then sold into sexual slavery. A year later, Seivan Salim, a Kurdish freelance photographer, went in search of women who had managed to escape. They pose for her, dressed in traditional Yazidi wedding dresses.

MESSAGE TO SYRIA

A plastic and audio installation, *Message to Syria* pays tribute to the civilian victims of the war in Syria. The installation is divided in two parts. The first invites us to commemorate through sounds and texts. The second part aspires to bridge the two banks, and invites each of us to leave a message to the Syrians, to one of the victims whose name appears on the tree’s leaves or to an imaginary person. These words, our thoughts, will be relayed to Syrians on the web. The installation’s intention is to open our eyes to the human reality of the conflict and to offer symbolic gesture of solidarity.

The number 64 represents the 4th of June 1989, day of the massacre, employed in China today as an acronym to avoid internet censorship. The soundtrack is a PLA song performed by Peng Liyuan, China's first lady, and the video ends with a reference to Jeff Widener's iconic Tank Man.

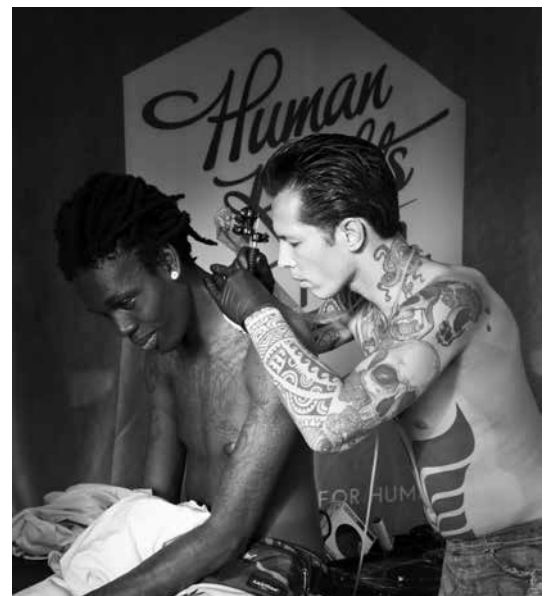

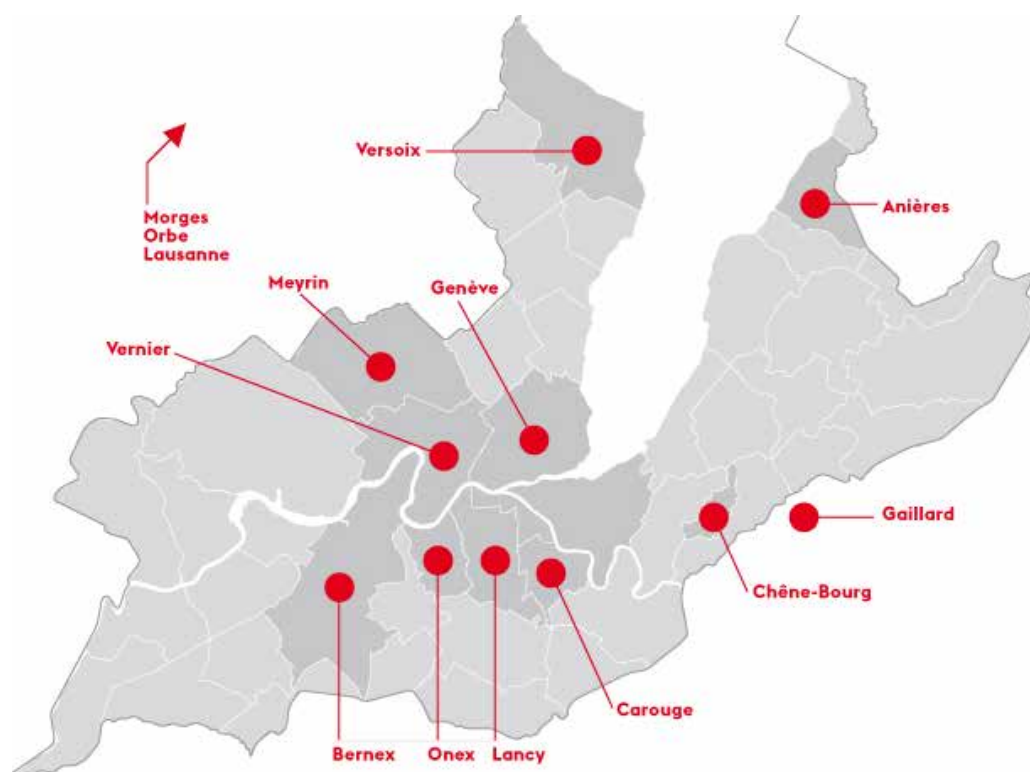

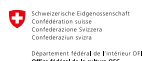
